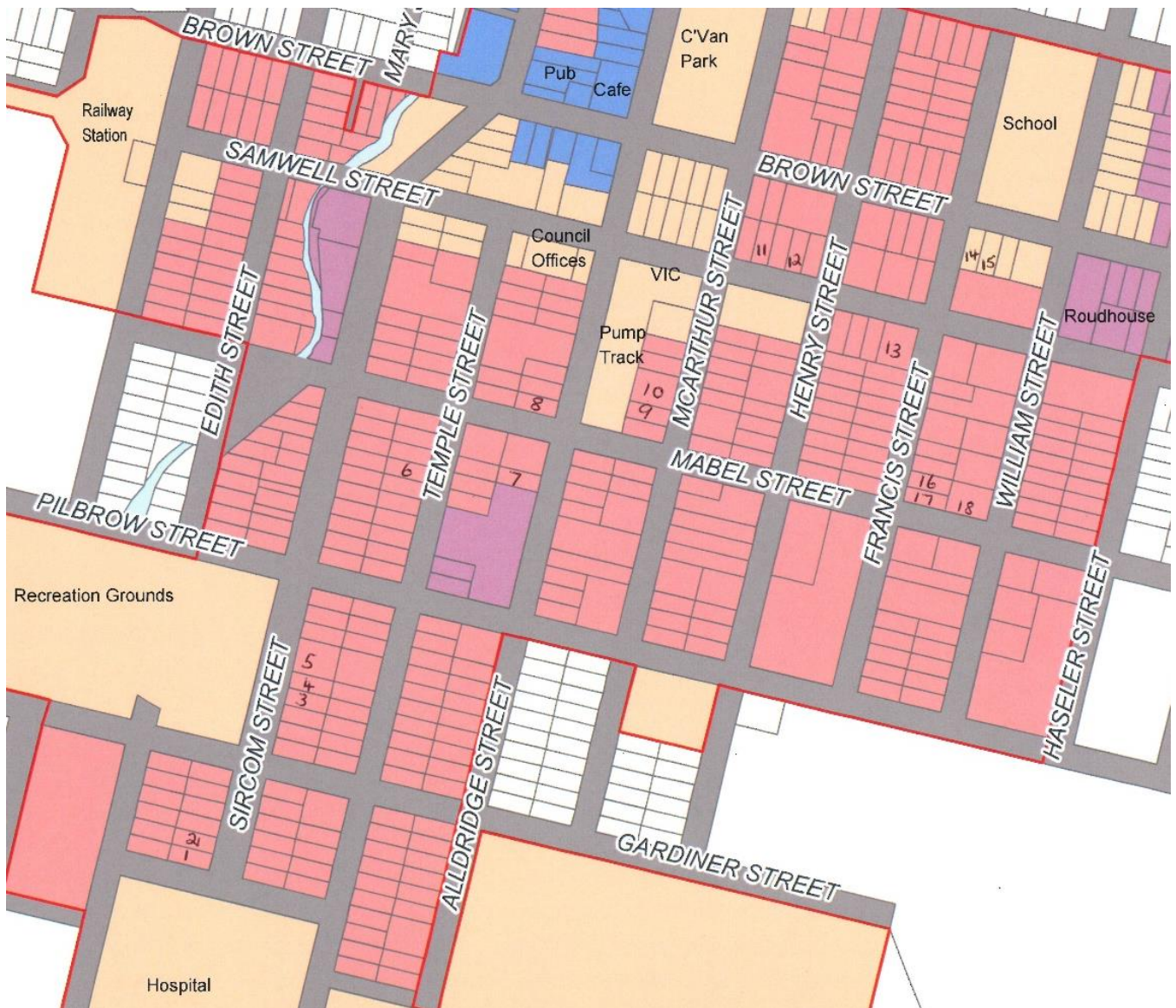
## 1. Introduction

Croydon Shire Council is offering for sale at a fixed price a number of individual parcels of Council owned vacant residential land allotments located in the township of Croydon, Queensland. Council at its Ordinary Meeting of 19 November 2020 resolved to dispose of the parcels of land by fixed price under section 236 of the *Local Government Regulation 2012* and in line with the valuation of land. Council may dispose of the land other than by tender or auction as the asset was previously offered for sale by tender and was not sold and will be sold for more than the highest tender bid that was received.

## 2. Vacant Residential Land Allotments

Council is offering for sale a number individual parcels of freehold land as described below at a fixed sale price. The properties are offered on an “as is” basis and interested parties are responsible for undertaking their own research to ensure the properties are adequate for their requirements.
