NOTICE OF ADOPTION OF MODEL LOCAL LAWS AND SUBORDINATE LOCAL LAWS

At its Ordinary Meeting held on 21 September 2023, Council resolved to:

1. Model Local Law No. 1 (Administration) 2023 and Subordinate Local Law No. 1 (Administration) 2023

Provide a legal and procedural framework for the administration, implementation and enforcement of local government local laws, subordinate local laws, and specified regulatory powers under legislation and provide for miscellaneous administrative matters such as application processes for specified prescribed activities.

2. Model Local Law No. 2 (Animal Management) 2023 and Subordinate Local Law No. 2 (Animal Management) 2023

Regulates and manages the keeping of animals and control of animals in the local government area.

3. Model Local Law No. 3 (Community and Environmental Management) 2023 and Subordinate Local Law No. 3 (Community and Environmental Management) 2023

Protects the environment and public health, safety and amenity within the local government area.

4. Model Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2023 and Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2023

Protects the health and safety of persons using local government controlled areas, facilities, infrastructure and roads and preserves features of the natural and built environment and other aspects of the amenity of local government controlled areas, facilities, infrastructure and roads.

5. Model Local Law No. 7 (Indigenous Community Land Management) 2023 and Subordinate Local Law No. 7 (Indigenous Community Land Management) 2023.

Enables the local government to regulate Reserve and Deed of Grant in Trust land including who may enter, be in or live in, the trust area, the management of camping sites and the designation and regulation of parks and reserves within the local government area.
